## Grand Valley State (Mich.) Takes Top Spot in the Second Fall Division II Learfield Sports Directors' Cup Standings

**CLEVELAND** – After the completion of six NCAA Championships, Grand Valley State has taken the lead in the second installment of the Learfield Sports Directors' Cup fall standings. In the most recent championships, the Lakers placed first in women's soccer and 33rd in women's volleyball increasing their point total to 290.

West Texas A&M is in second, trailing Grand Valley by 74 points. The Buffs have accumulated a total of 216 points after finishing second in women's volleyball, fifth in women's soccer and ninth in men's soccer.

Massachusetts Lowell is in third with 210 total points, after finishing 33<sup>rd</sup> in both women's soccer and women's volleyball.

Rounding out the top-five with a total of 208 points each are Colorado School of Mines and Metropolitan State (Colo.). The Orediggers of Colorado finished fifth in women's soccer, 17<sup>th</sup> in men's soccer and 33<sup>rd</sup> in women's volleyball.

The Roadrunners of Metropolitan State added 128 points to their previous total of 80 after placing ninth in women's soccer and men's soccer.

Six of the seven fall NCAA championships have been completed with the following institutions capturing titles: Adams State (men's and women's cross country); Bloomsburg (Pa.) (women's field hockey); Grand Valley State (women's soccer); Fort Lewis (Colo.) (men's soccer); and Concordia (Minn.) (women's volleyball).

The Learfield Sports Directors' Cup was developed as a joint effort between the National Association of Collegiate Directors of Athletics (NACDA) and *USA Today*. Points are awarded based on each institution's finish in up to 14 sports -- seven women's and seven men's.

The final Division II full standings will be released Wednesday, December 23.
